### Committee Update

- Dinner in SF: Monday night, 7 Fang’s
- GE proposed regulations are out (70ish pages), WASFAA is working on official Comments
  - Update from Kevin Jensen (WASFAA FIC, FinAid rep on GE Neg. Committee): Consensus from negotiators is not expected – thus Regs will come out directly from ED. Proposed regs are similar in nature to previous, some additional complexity shouldered by ED. Some concern that “these proposed regs include provisions for borrower relief that will place financial burden on institutions.”
- ED’s College tour
  - Should send info out the membership – survey concerns
    - Background information
    - How do you anticipate this would affect you?
    - What would you change the implementation?
    - What concerns you about tying performance to funding?
  - Reporting burden, how to get accurate data
  - These metrics are not easily accessible or conclusive
- Concerns about the new Verification Group 6?
  - Needs clarification
  - Many schools already have institutional policies to follow-up with low income students
- Some concern over manual updating FAA Access for ID statement
- Review of goals – we did well!
  - Recommending surveying membership again for guidance on direction for 2014
- Some concern over CASFAA’s focus on the CC and Prop segments
  - Need consistent input from segmental reps to ensure representation – an initiative for 2014?
  - Reaffirmed the need to introduce those on the call (name, roll, employer, segment)
